ASSIGNMENT OF LIEN . 1. The Assignor must be listed as secured party on the application for title or on the current certificate of title. 2. The Assignor must complete section A and list the name and address of the Assignee in section B. 3. The assignment must be submitted with the current certificate of title. 4. Fees: \$1 plus \$10 filing fee.
