For companies incorporated under Section 8 of the Act, the board of directors may decide the following ...

Procedure for Passing a Board Resolution by Circulation ...

A resolution by circulation is passed when such approval is urgent in nature and cannot be kept on hold for passing such resolution in the ensuing Board meeting. Sometimes such matters are discussed in the earlier Board meetings but a resolution to that effect is not passed.

Compliance Checklist for Passing of Resolution by Circulation

Passing of Resolution by Circulation . 175. (1) No resolution shall, unless the draft law, together with the necessary documents, has been circulated to the Board of directors or members of the committee, by circulation, at their addresses registered with the Company in India by hand delivery, post or courier, or through such electricity, unless it has been transmitted by circulation or circulation.

Passing of Resolution by Circulation during the CoVID ...

For a Resolution under circulation to be passed, it should be approved by a majority of dis-interested Directors, who are entitled to vote. The Resolution, if passed, shall be deemed to have been passed on the earlier of: Ø the last date specified for signifying assent or dissent by the Directors; or

Passing of Resolution by Circulation Under Companies Act ...

Resolution by Circulation means taking of approval of Board through email or fax instead of Board Meeting. Passing of resolution by circulation is at the sole discretion of the Board. Now, be it passing of resolution by circulation or by postal ballot or by e-voting, Companies Act, 2013 prescribes certain procedures/criteria to be fulfilled by the companies.

PASSING OF RESOLUTION BY CIRCULATION - LegalDhanda

Circular Resolution is an alternative method of obtaining the approval of the Board of Directors. Resolution by circulation means passing a resolution by the Board without holding the meeting of the Board of Directors but by the circulation of the resolution along with the supporting papers to all the directors for approval and signature.

Resolution by Circulation - Assignment Point

Passing of resolution by circulation will be treated as if it had been passed at a duly convened meeting of the Board or Committee but that does not dispense with the requirement for the Board to meet for the Board Meeting which is to be held at least once in a quarter. It can be noticed that not much has changed in this regard.

Passing of Resolution by Circulation under Companies Act ...

Passing of resolution by circulation is a facility available to the directors to take the urgent decisions without convening the Board meeting. The new Act has widened the scope of resolutions to be passed by circulation.

Passing of resolution by circulation: The Act and the ...

Resolution-by-circulation means the resolution which is passed by the circulation among the directors or members of the Board. Generally, the resolution was proposed to be passed when there is urgency or sometimes the resolution by circulation is preferred to avoid the procedural requirements of convening the physical Board Meeting.

In order to pass a resolution by circulation, the draft of the resolution proposed to be passed along with the necessary documents if any, shall be circulated to all the directors of the Company or the members of the committee of the Company.

Passing of resolution by circulation. (1) No resolution shall be deemed to have been duly passed by the Board or by a committee thereof by circulation, unless the resolution has been circulated in draft, together with the necessary papers, if any, to all the directors , or members of the committee, as the case may be, at their addresses registered with the company in India by hand delivery or by post or by courier, or through such electronic means as may be prescribed and has been approved ...

Section 175. Passing of resolution by circulation ...

Passing of Resolution by circulation shall be considered valid as if it had been passed at a duly convened Meeting of the Board. Consent may be executed in one or more counterparts and by each director on a separate counterpart, each of which shall be deemed to be an original and all of which taken together shall be deemed to constitute a single document.
